

## SECTION 04 - FIRST AID MEASURES

<b>Acute toxicity (Ingestion)</b>	Excessive salivation, nausea, vomiting, diarrhea, stimulation of all muscles followed by flaccid paralysis, heart rhythm disturbances (tachycardia and ventricular fibrillation), hypertension, hypokalemia, death from cardiac or respiratory failure.
<b>Chronic exposure effects / symptoms</b>	The fatal dose of barium carbonate is 0.8 g and death occurs within 2 to 12 hours. The symptoms of overexposure are excessive salivation, vomiting, severe abdominal pain, violent diarrhea; increased blood pressure; tinnitus, giddiness, vertigo; muscle twitching, convulsions, paralysis; dilated pupils; confusion, somnolence; cardiac arrest; death due to respiratory failure.
