## SECTION 04 - FIRST AID MEASURES

## SECTION 07 - HANDLING AND STORAGE

<b>Conditions for safe storage</b>	Hygroscopic. Store in a cool, dry place. Keep container tightly closed and store away from heat, moisture, and incompatible products. Keep container tightly closed in a dry and well-ventilated place. Do not store near acids. Air and moisture sensitive.
<b>Methods of handling</b>	Always open containers slowly to allow any excess pressure to vent. Avoid formation of dust and aerosols. Provide appropriate exhaust ventilation at places where dust or vapor is formed. Avoid ingestion and inhalation.
