


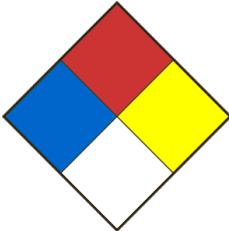

SECTION 04 - FIRST AID MEASURES

SECTION 07 - HANDLING AND STORAGE

Conditions for safe storage	Store in cool place. Keep container tightly closed and store away from heat, water, moisture, and incompatible products (ref. section 10). Protect from the sun's rays. Reacts violently with water. Keep container tightly closed in a dry and well-ventilated place.
Methods of handling	Corrosive. Wash thoroughly after handling. Avoid contact with the skin, eyes and clothes. Avoid ingestion and inhalation. Wear personal protective equipment when handling. Always ensure good ventilation. Apply the usual standard hygiene rules: Wash your hands after use. Do not eat or drink during use.

- Skin	Severe burns and tissue ulcerations. May be fatal, if the extent of the burns is considerable.
- Inhalation	Spasms, irritation and inflammation of the nose, throat and lungs. Edema of the larynx and bronchi. Chemical pneumonitis and pulmonary edema that can lead to death.
Acute toxicity (Ingestion)	Corrosion and ulceration of the mouth, throat, esophagus, stomach and abdominal wall. Dysphagia, kidney damage, abdominal pain, cramps, diarrhea, melena, hematemesis, anuria, possible perforation of the esophagus and stomach, convulsions, salivation, stupor, circulatory collapse, unconsciousness, coma and can lead to death .
